1. Welcome (Jim Walker)

6/15/21: Jim provided welcome remarks and introduced VolOps Staff Beverly Smith and Jeff Yates.

2. Volunteer Operations Updates (Beverly Smith / Jeff Yates)

- Calendar, Events & Annual Meeting

6/15/21: Beverly discussed the National Meeting plans and stressed “hopefully the last” virtual Zoom Meeting for a major TU event. The National Meeting will be on Thursday, September 30 and will coincide with a week-long set of activities focused around engagement. This will include the NLC Annual Business Meeting proposed for Wednesday, September 29.

- Recharter of Chapters – September 2021

6/15/21: Jeff reviewed the Chapter “re-charter” process and reminded everyone that as of 4 years ago, it was decided that all Chapters will be re-chartered at the same time. Councils should be making the recharter decision for each Chapter. He also highlighted the importance of Councils ensuring they have exhausted any improvement plans with each Chapter before making a final “de-charter” decision. Jeff also provided some basic Chapter statistics and stressed the best digital pivoting Chapters had a good strategic plan, a good succession plan and good leadership practices.

- National Zoom Account

6/15/21: Jeff reviewed the new National Zoom Account which will provide more licenses allowing for multiple organizational Zoom Meetings at one time as well as “one click join access.”

6. Membership (Jim Walker / Beverly Smith)

6/15/21: Jim discussed the history on the membership retention data process as well as progress over the past year.

- Retention Progress

6/15/21: Based on latest data reports, membership retention is up 6%. Further, Jim noted that Trout Unlimited is at the top of the list when compared to 12 like-minded conservation organizations tracked

by Lori Held. Actions taken by the organization over the course of the last year include grassroots social media outreach & events, National media events and other online events and it is believed that these actions have contributed to the success. Lori will continue to provide data on a quarterly basis and this information will be made available to respective states around the August timeframe.

- Engagement Strategy

6/15/21: Beverly praised the efforts of the team for pulling together these statistics. She also added that the continued effort of changing cultures has also led to the retention improvements. Beverly also explained how the new strategic planning process along with a new understanding of how people want to contribute to TU will change how we look at membership. She discussed “supporters” which are non-members who give into TU in a different way such as event participation and social media outreach. She discussed the new events tool which was developed for chapters to capture these supporters and tie them back to their respective memberships. - Program, expansion & partners

6/15/21: Mike provided an excellent overview on TU’s Service Partnership (SP) including a short video overview as well as presentation focusing on the evolution of the formally Veteran’s Services Program to the SP. TU now offers the same benefits as with our Military to those of our fire, law enforcement and medical communities which includes a free one-year membership with the same benefits as paid members.
